Purpose:

The CWE Scholarships are awarded every year to qualifying students whose calling closely matches the mission of the Christian Evangelistic Association:

“The specific purpose of the Christian Evangelistic Association is to propagate the Gospel of Jesus Christ, in accordance with the Holy Bible, in customs and traditions of Evangelical Christianity, as an evangelistic association and missionary outreach.”

Qualifications:

- Applicant must have a growing, victorious testimony because of the indwelling Christ
- Applicant shows a relevant and vibrant Christian faith as attested by a Pastor’s Recommendation
- Applicant must be a full-time student at LABI College
- Applicant must have a personal sense of urgency about fulfilling the Lord’s Great Commission as stated in Matthew 28: 19-20:

“Go therefore and make disciples of all the nations, baptizing them in the name of the Father and of the Son and of the Holy Spirit, teaching them to observe all things that I have commanded you; and lo, I am with you always, even to the end of the age. Amen.”

Award Specifics:

- The Scholarships are awarded yearly to all qualifying applicants. No limit.
- The extent of the Scholarships awards is assigned and announced by May 1st of each year.
- Funds are sent directly to the LABI College Foundation to be credited to applicant’s student account
- Although the CWE Scholarships are not renewable, recipients may reapply
- The recipient must attend the yearly CWE Conference at LABI College
